- Fifth Street Pull-Out for parents. By-Law Article 10.A.4 states that "there will be no parking to load or unload children within 50 feet of any stop sign." Email from member whose home this parking is in front of. Discussion.

 - o Do parking sites have to be on the side of the street where Stop signs are located?
 - o If yes, how do we raise deep ditch areas to road height?
 - o Do we need more research before deciding to proceed with sites?
- Stop signs/Meeting signs Sign on south corner of 7th facing wrong direction; meeting sign down on 5th and Park. To be repaired in Spring.
- Estimated assessment income for 2024-2025 \$95.723.
- Mailbox Relocation -- Seek volunteers for a committee to determine proper placement per Deschutes County standards/USPS requirements and to propose a plan for moving boxes to meet standards (including safety and snow removal concerns).
